



#### **EMN CONFERENCE 2012**

Immigration of International Students to the EU Monday 29<sup>th</sup> October – Tuesday 30<sup>th</sup> October 2012, Grecian Park Hotel, Paralimni, Cyprus

### 1. INTRODUCTION

This Concept Note, updated for the 57<sup>th</sup> EMN NCP meeting of 18<sup>th</sup> September 2012, provides an overview of the likely format and focus of the EMN Conference in 2012, which will now be held in Paralimni (Protaras area), Cyprus on Monday and Tuesday 29-30 October 2012, and organised within the framework of the Cyprus Presidency of the Council of the EU (1<sup>st</sup> July 2012- 31<sup>st</sup> December 2012) according to the priorities of the Presidency. The overall theme for the Conference is 'International Students', tying in also with the EMN's main study for 2012. Practical Considerations are given in <u>Annex</u>.

The benefits to both sending and receiving countries of allowing third-country nationals to take up education and training opportunities in Europe are well documented, and include, for example, promoting Europe as a world centre of excellence for studies and vocational training, and allowing migrants and host Member States to benefit from mutual enrichment through intercultural exchange. The Communication on the Global Approach to Migration and Mobility<sup>1</sup> makes extensive reference to students under its first pillar, *Organising and Facilitating legal migration and mobility*.

International students now represent a substantial proportion of the non-EU population in many EU Member States. For example, looking at data on first-time issued Residence Permits, in 2010 almost 2.5 million first residence permits were issued to third country nationals (5% more than in the previous year). The number of permits issued for the purpose of study represented some 20.6% of the total number of permits issued, against 32.5% for remunerated activities, 30.2% for family reasons and another 17% for various other reasons, e.g. protection-related, residence without the right to work, etc. The importance of international students to the economy, the labour market and the educational systems of EU Member States, all point to the increasing relevance of this topic to policymakers at both National and EU levels, and specifically to EU policymakers in light of the review of *Council Directive 2004/114/EC* which regulates the conditions of admission of non-EU students to study in EU Member States. The variation in the conditions of admission and stay also highlight the potential for the identification and sharing of good practices across the EU.

## 2. AIMS AND OBJECTIVES OF THE EMN CONFERENCE 2012

The Conference will serve to inform on the development of a proposal amending the Students and Researchers Directives. It will be a high-profile event, and will aim to specifically support the policymaking process in the field of immigration and international students, notably in the development of the planned review of Council Directive 2004/114/EC. It will also respond to the priorities assigned by the Cyprus Presidency.

The Conference will further raise awareness about the work of the EMN and engage with a wider audience of policy makers and practitioners at EU and national levels, and will aim to highlight and create synergies with the work of other EU and National institutions and agencies relevant to the theme.

The Conference Conclusions and the final Synthesis Report of the related EMN Study will incorporate the outcomes from the Conference. The Conclusions will be forwarded to all delegates as a tangible outcome

from the Conference, and as a prompt to continue the engagement of a wider audience in the work of the EMN.

### 3. <u>ISSUES TO BE ADDRESSED</u>

A number of key issues will be addressed, based on the priorities of the Cyprus Presidency and those elements of the EMN study that are deemed to be of most pressing need for policy makers. These will include:

- Measures to attract International Students / identifying what the most effective triggers are for student mobility to the EU, including access to information and information sources and facilitate / International Students' admission (entry and residence);
- ➤ Rights and responsibilities of International Students in EU Member States (access to health and welfare benefits; family reunification);
- > Students' access to the labour market, both during and on completion of study;
- > International co-operation to facilitate mobility within the EU and with third countries;
- Maximising positive impacts of International students in the EU, and minimising negative impacts and risks

# 4. <u>STRUC</u>TURE OF CONFERENCE

The Conference will be opened by the Cyprus Minister of Interior, Mrs Eleni Mavrou, who will present an overview of the event, its aims and objectives, and what it is expected to achieve. The intention is then for Commissioner Androulla Vassiliou to provide a policy overview of key relevant issues and developments.

The opening plenary will then be followed by a high-level, round-table plenary discussion. The Commissioner will join this session as part of a panel of experts comprising or representing European Universities, third country students, plus other relevant parties. The panel will discuss, for the benefit of the audience, relevant topics, and will respond to questions from the audience.

The Conference will then allow for <u>four key themes</u> to be discussed in depth. These themes will draw on the emerging findings from the literature review and submitted National Reports in relation to the EMN Study: <u>the Immigration of International Students to the EU.</u>

The subsequent themes will reflect the main interests of policymakers but will be guided by the framework of the priorities of the CY Presidency and the CY EMN NCP, working in co-ordination with EMN NCPs.

Where possible and relevant, the Conference will aim to allow for the direct representation of International Students, to allow the audience to share the perspective and impressions of young newcomers to the EU.

A concluding session will be held on the second day, to present back to delegates the main conclusions from the Conference and to set out the next steps for the Synthesis Report.

An opportunity will be provided for delegates to exchange information about their organisations (e.g. displaying their products) during the planned lunch break.

An informal EMN NCP meeting will also take place on the afternoon of Tuesday 30<sup>th</sup> October 2012.

#### 5. PARTICIPANTS

The Conference is likely to attract the following participants: EMN members; representatives of Institutions working in the main thematic areas; (GOs, agencies, NGOs etc.); relevant EU, National, International Bodies and NGOs e.g. COM (DGs HOME, EAC, Eurostat), Eurocities, FRA, IAU, Erasmus Mundus Alumni Association, European Students Association, CEDEFOP, ACP Observatory on Migration, Migration Policy Centre and researchers in the field of international student migration. Please note that this list is not exhaustive.

The Conference will accommodate up to 130 delegates; up to three participants on average per EMN NCP envisaged. Simultaneous interpretation (speak and listen) GR-EN-FR for the Conference will be provided by the CY EMN NCP.
