Dealing with the changing influx of asylum seekers Key measures taken by Member States



Border management:

- > Increased border control and surveillance
- > Awareness raising campaigns



Registration:

- > New infrastructure and equipment
- > Faster procedures



Reception:

- > New centres and expansion of existing ones
- > Temporary reception solutions



Asylum procedure:

- > Procedural simplification
- > Amending list of safe third countries



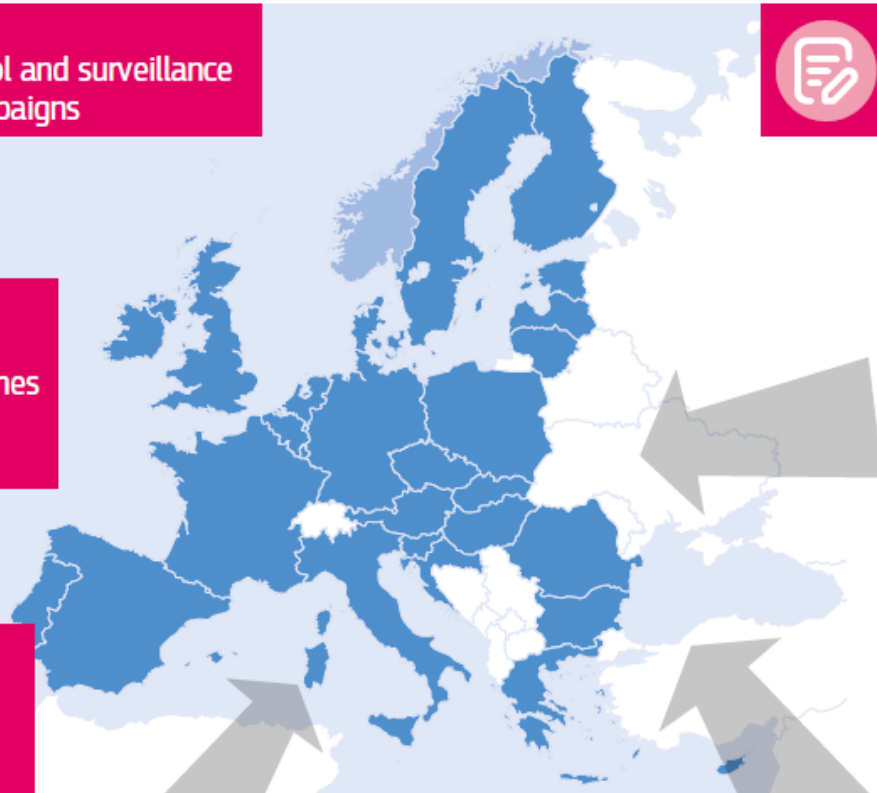
Integration:

- > Increased funding
- > Improved access to the labour market



Wider reception services:

- > Improved health, social and psychological support
- > Services built on existing capabilities and activities

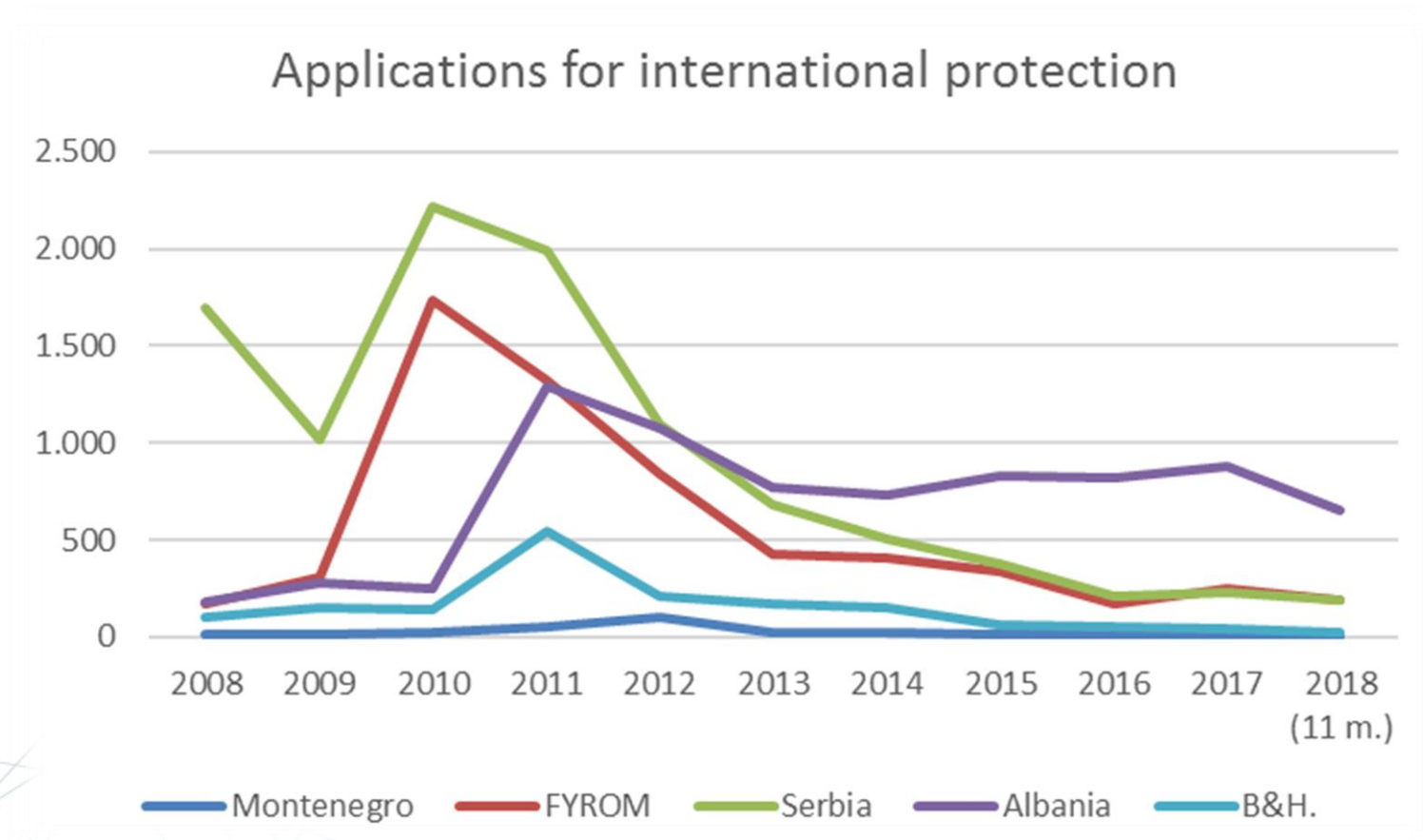

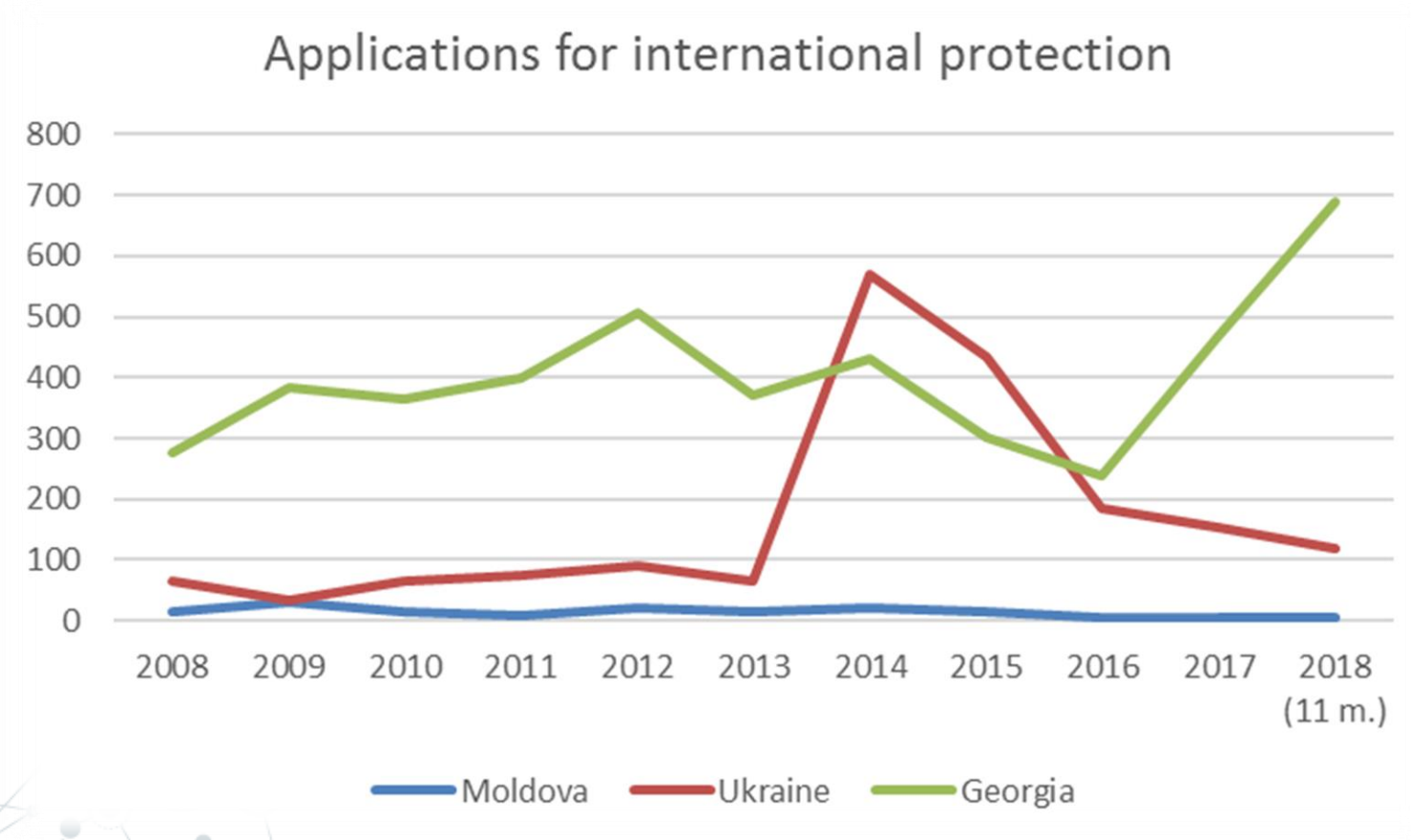

- ...

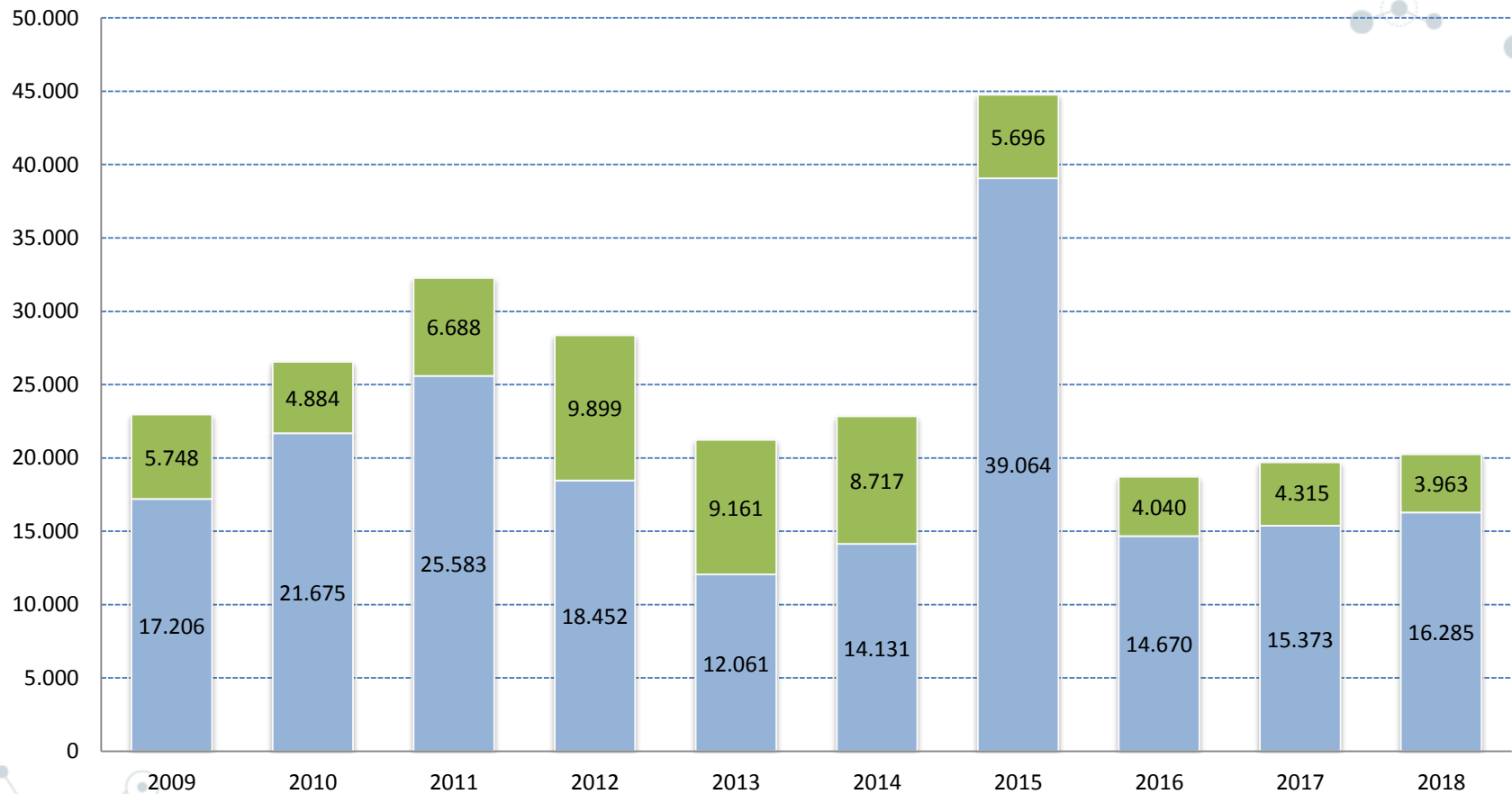

Applications for international protection in Belgium (source CGRS)

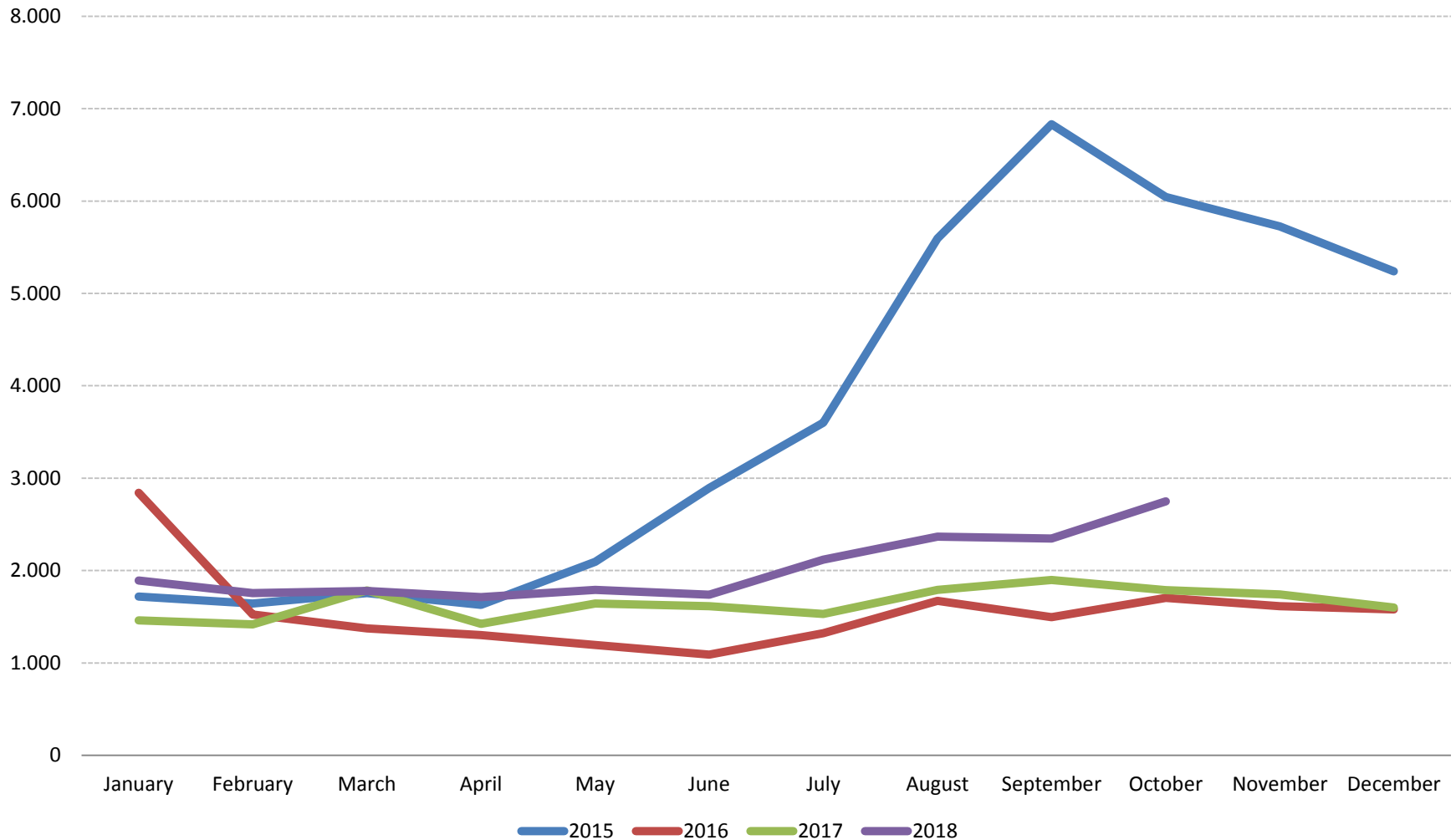
Yearly evolution of the number of persons who filed an application for international protection in the period 2009-2018



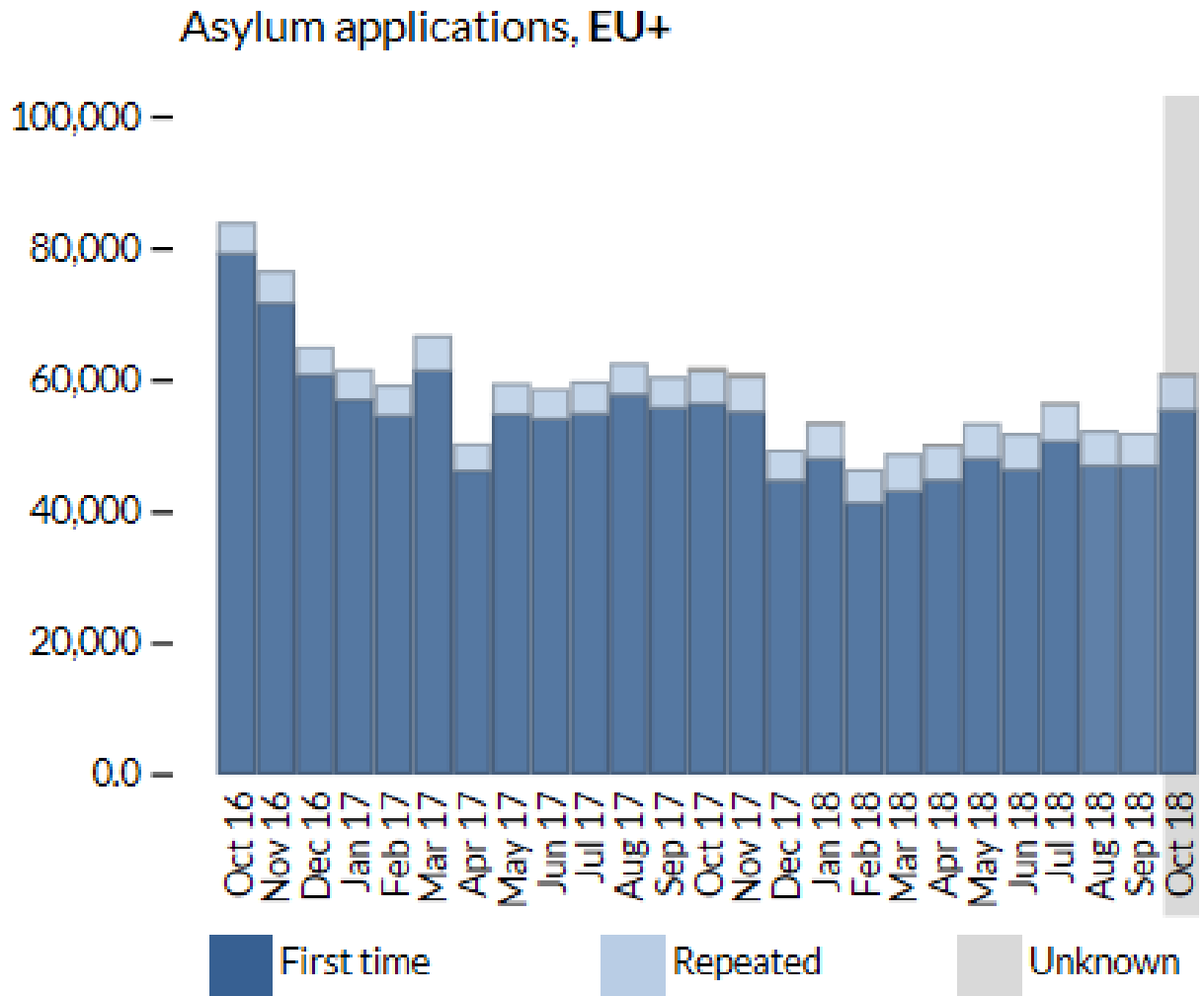
■ Number of persons who filed a subsequent application for international protection

Applications for international protection in the EU+ (Oct. 2016 - Oct. 2018) (source EASO)

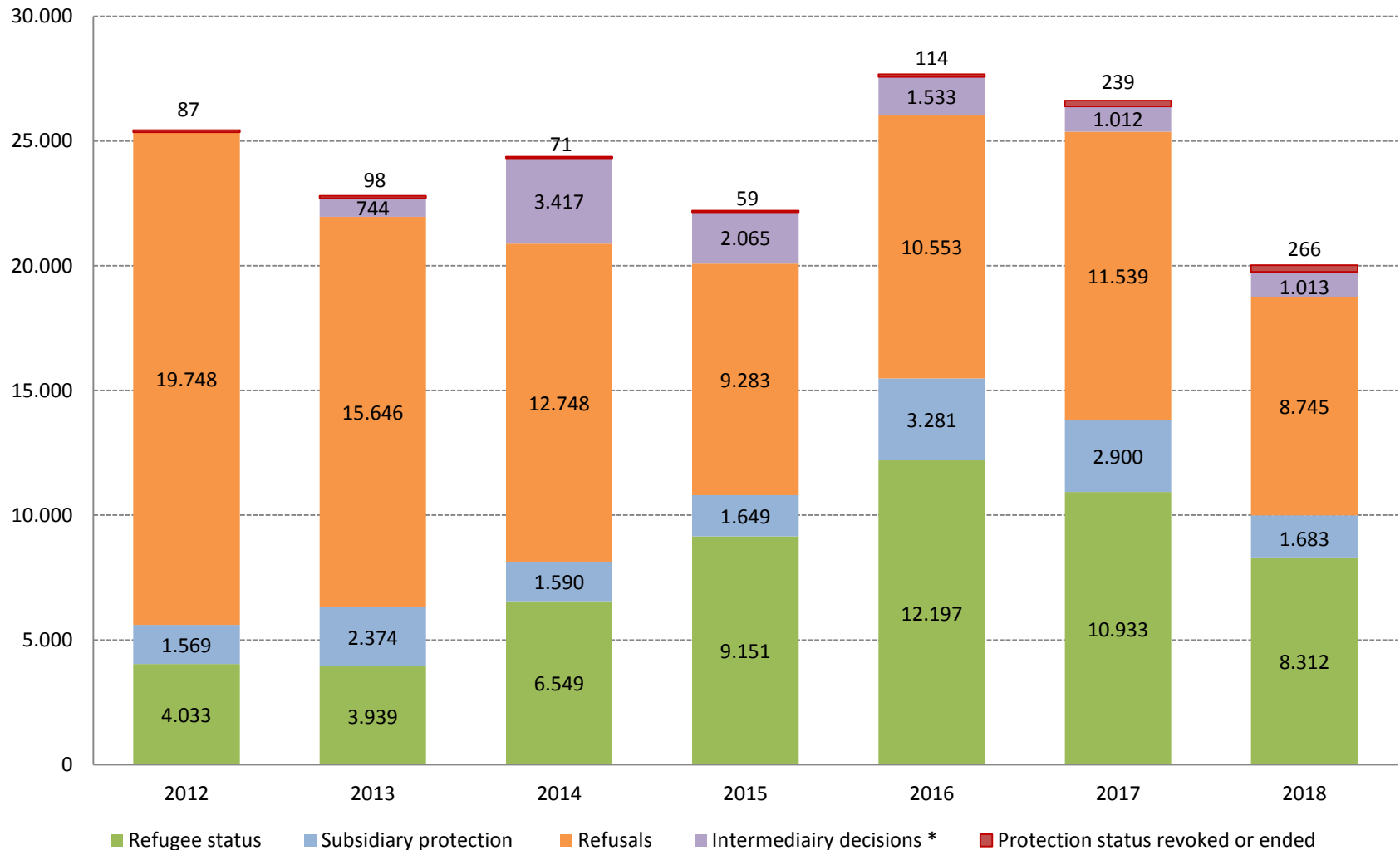

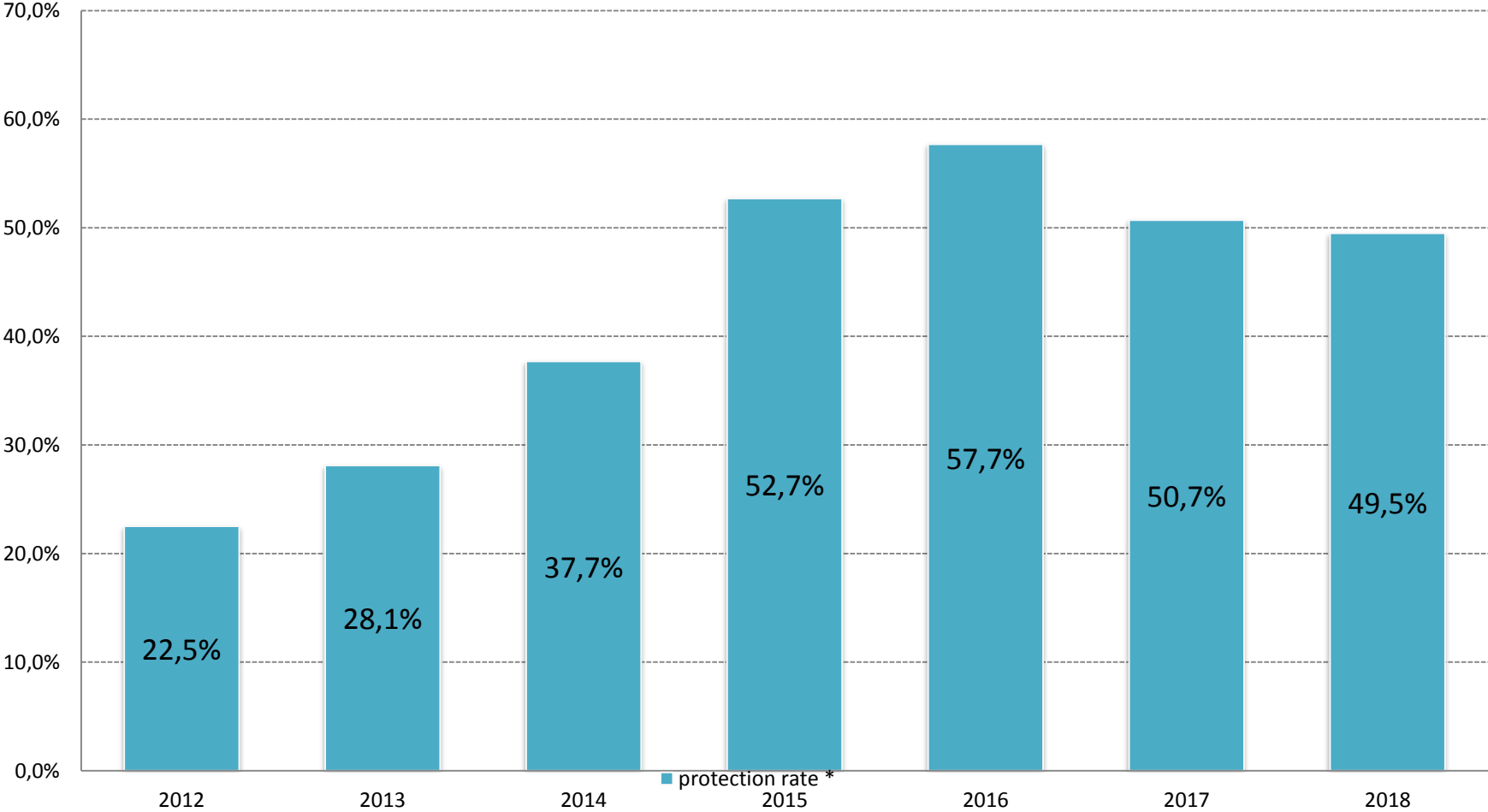
Decisions in Belgium (first instance) (source CGRS)

Evolution of the type of decisions taken by the CGRS (in number of persons) 2012 – Nov. 2018



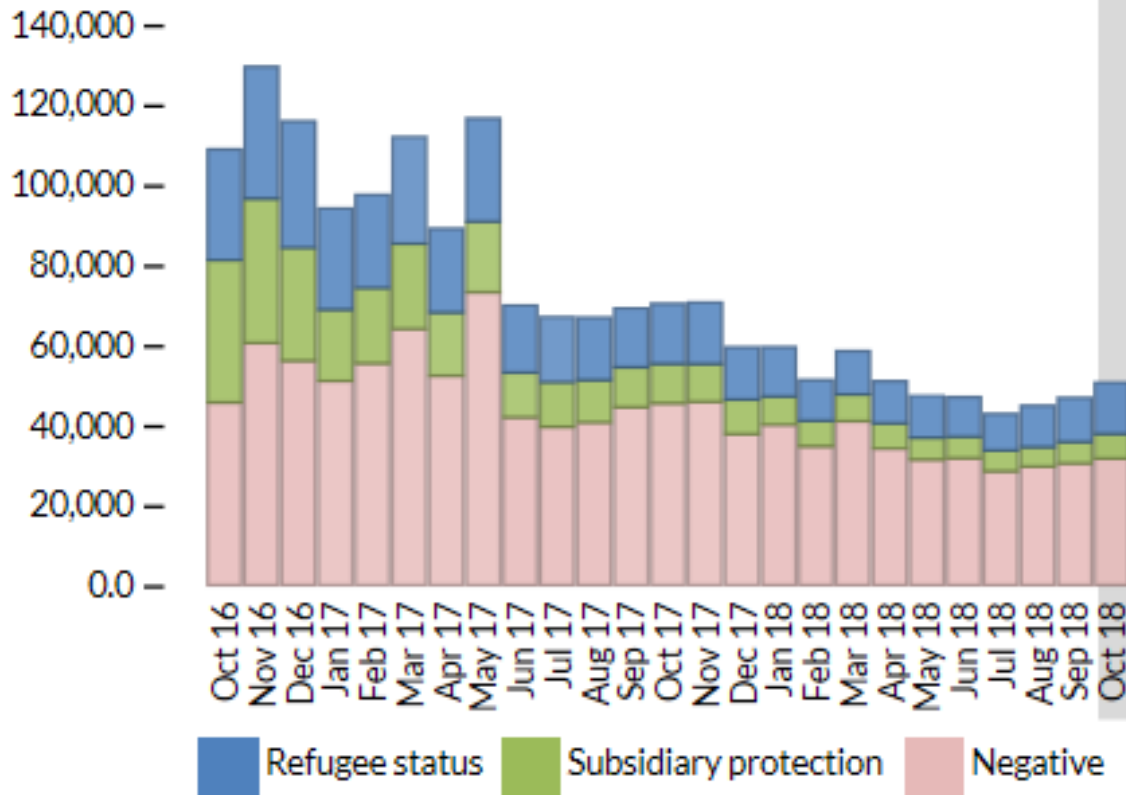

Evolution of the protection rate of the CGRS in the period 2012 - Nov. 2018



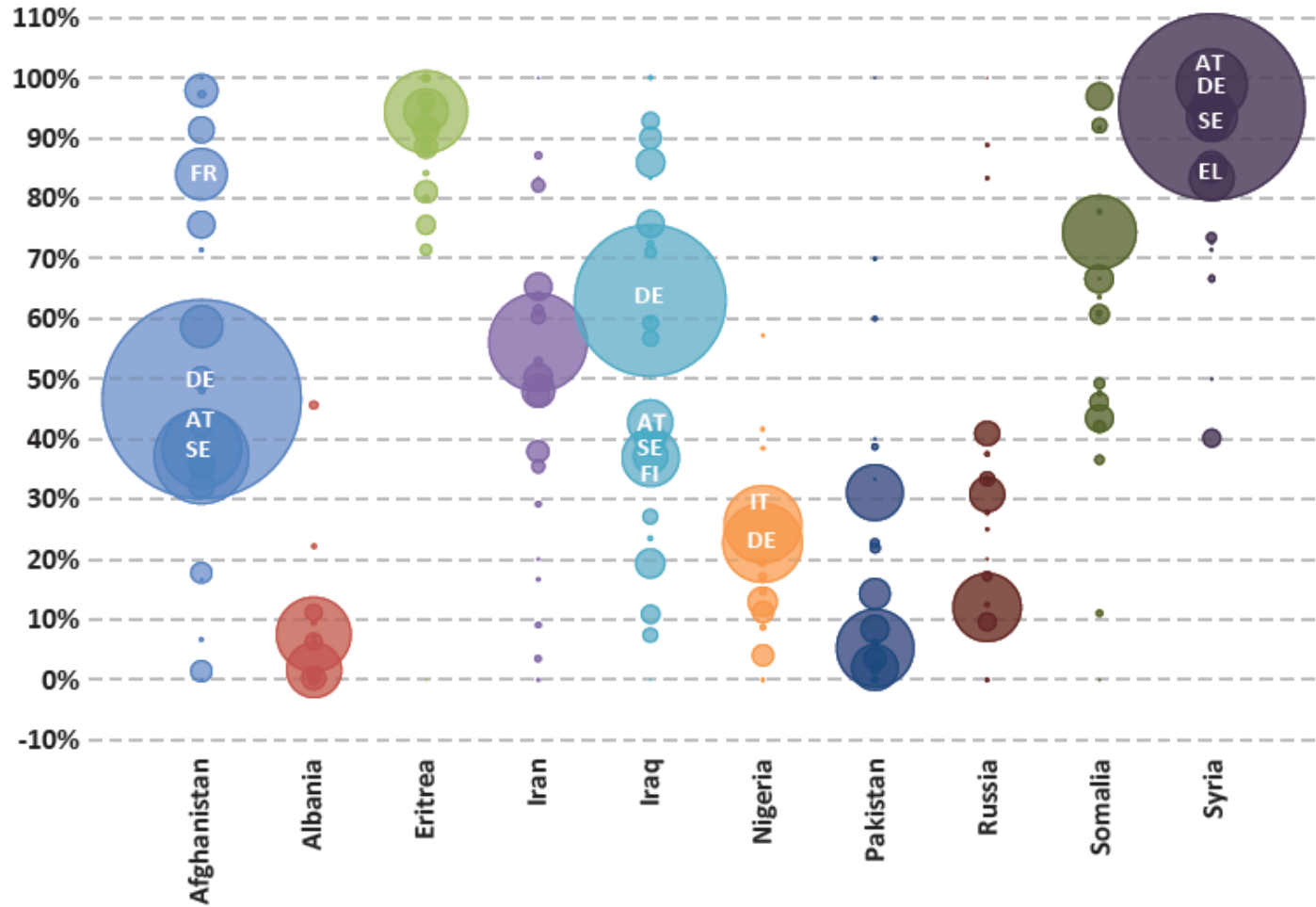

First-instance decisions, EU+

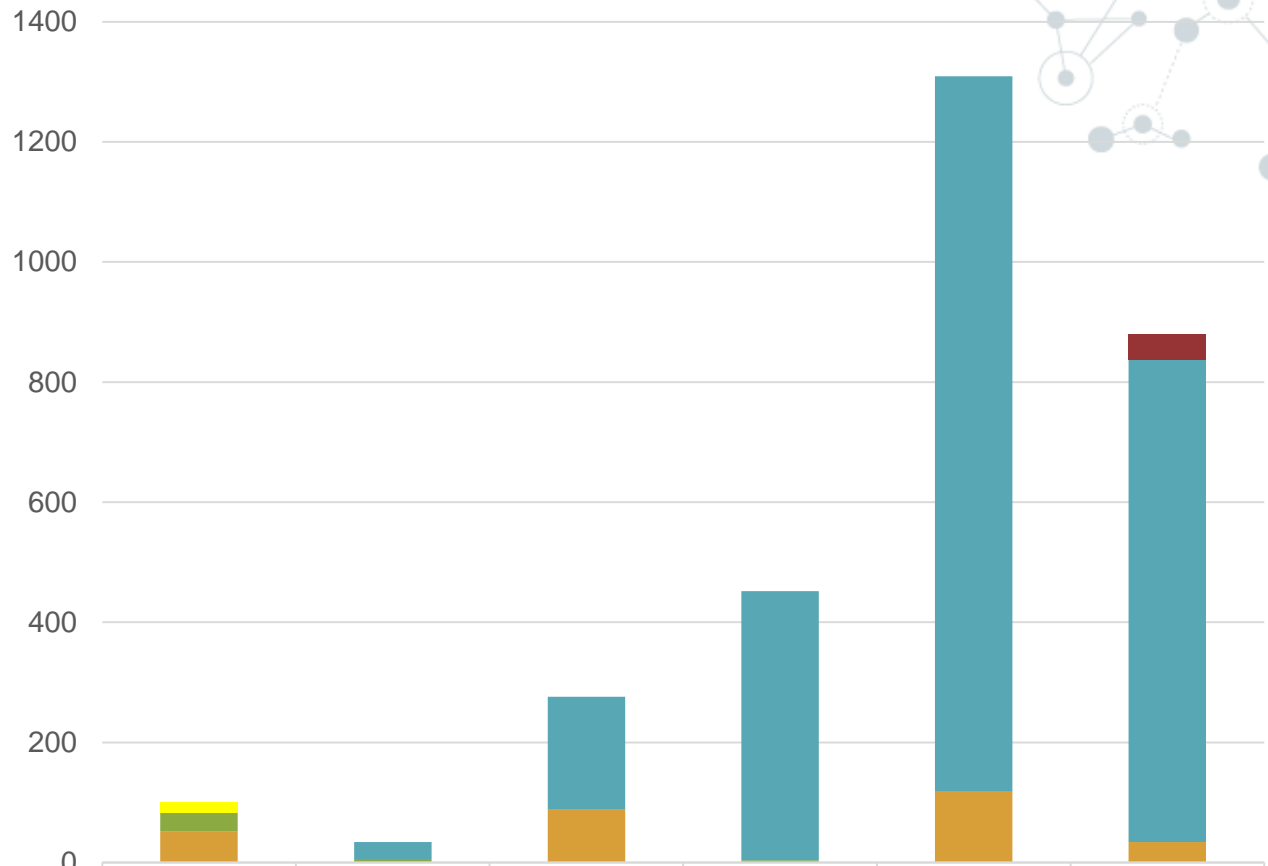


Decisions in the EU+ (first instance) (source EASO)
