






Asielprocedure in België (Internationale bescherming)





Evolutie aantal personen dat enkel- en meervoudige asielaanvragen indiende 2009-2017










Evolutie van het type asielbeslissing (in personen) 2012-2017






Evolutie van de beschermingsgraad CGVS 2012 - 2017






Relocatie (2015 - 28 nov. 2017): 1.085 personen (bron: COM, CGVS + eigen bewerkingen)



- Relocatie uit Griekenland = hoofdzakelijk Syriërs
- Relocatie uit Italië voornamelijk = hoofdzakelijk Eritreërs
- Totaal EU-niveau: 10.720 personen gereloceerd uit Italië en 21.323 uit Griekenland (28/11/2017)



Resettlement 2014 - 2017: 2083 personen (bron: CGVS/eigen bewerkingen)



- Aankomsten 2014 (35) -> 2015 (276) -> 2016 (452) -> 2017 (1320)
- Syrische vluchtelingen uit Turkije, Libanon, Jordanië, Egypte, Irak
- Congolozen uit Burundi (2015,2016) en Oeganda (2017)
