



Inventory on Bilateral Readmission Agreements signed by or entered into force in EU Member States in 2014-2021

TECHNICAL INFORMATION

This dataset contains information on bilateral readmission agreements signed and/or entered into force in 2014-2021 in EU Member States.

The data was collected by the European Migration Network (EMN) National Contact Point (NCP) for the Netherlands in August 2021 - January 2022, and validated by EMN NCPs in January 2022.

NCPs from 23 Member States have contributed to and validated information in this dataset: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Netherlands, Poland, Slovakia, Slovenia, Spain, Sweden.

Scope

This dataset includes information on bilateral readmission agreements signed or entered into force in the period 2014-2021, including bilateral implementing protocols to EU Readmission Agreements. Bilateral readmission agreements may be signed by one Member State with a third country, or by a bloc of Member States with a third country (e.g. Benelux readmission agreements). EU Readmission Agreements are excluded from the scope. Reporting on Memoranda of Understanding (MoU) was optional.

Source

Information in this dataset is based on the inventory from Prof. Cassarino, retrieved with permission from https://www. jeanpierrecassarino.com/datasets/ra/ (user registration required). These data have been verified and updated by National Contact Points of the European Migration Network in August 2021 - January 2022.

These data have been verified, updated and complemented by EMN NCPs to ensure all information is correct for agreements signed and/or entered into force since 2014. In addition, NCPs have added information on the scope of the agreement (readmission of nationals of the third country and/or readmission of other third-country nationals) and added the source of the agreement, if possible.

Legend

For each agreement, the following information is provided:

Country the name of the third country with which the agreement was signed

Type of agreement the type of agreement (e.g. bilateral

readmission agreement, bilateral implementing protocol to an EU Readmission Agreement, Memoranda of Understanding)

Signature date the date the agreement was signed by the Member State

Status the status of the agreement (e.g. signed, in force, suspended)

Date entry into force the date on which the agreement entered into force in the Member State (if applicable)

Readmission of nationals of the third country whether the scope of the agreement includes readmission (from the Member State) of irregularly staying nationals of the third country

Readmission of other third-country nationals whether the scope of the agreement includes readmission (from the Member State) of nationals of other countries to the third country, for example persons who transited through the third country

Source the source where NCPs extracted information on scope.

(This is usually the agreement itself, but not always. E.g. in the case of Implementing Protocols to EU Readmission Agreements, information on scope may be extracted from the EU Readmission Agreement)
